MEMBERSHIP

Membership in WMPA is based on a calendar year beginning January 1st. Membership status is subject to review by the Board of Directors. All WMPA members are expected to read and abide by the WMPA Model Code of Ethics and Professional Conduct, which can be viewed on WMPA's Web site.

VOTING MEMBERSHIP \$65.00

Any person employed as a paralegal at the time of application or renewal. Voting members shall have the right to vote for election of officers and other matters of importance to WMPA, as well as the right to hold an elected office.

ASSOCIATE \$65.00

Any person who has been employed as a paralegal or has graduated from a paralegal training program and is not employed as a paralegal at the time of application or renewal. An associate member shall not be entitled to vote or hold office, but shall have all other privileges of voting membership.

STUDENT \$35.00

Any person enrolled in a paralegal training program or serving a paralegal internship at the time of application or renewal. A student member shall not be entitled to vote or hold office, but shall have all other privileges of voting membership.

SUSTAINING \$150.00

Open to all individuals or organizations concerned with the betterment of the paralegal profession. A sustaining member shall not be entitled to vote or hold office, but shall have all other privileges of voting membership.

HISTORY AND PURPOSE

The Western Massachusetts Paralegal Association (WMPA) is a voluntary, nonprofit association formed in 1988 to promote the professional development and continuing education of paralegals in the Western Massachusetts area. The goals of the WMPA are:

- To promote high professional and ethical standards in the education, training and employment of paralegals.
- To serve as a source of educational information for members, the legal community and the general public.
- To provide opportunities for the mutual association of paralegals and paralegal students to promote the general professional interests of paralegals.

DEFINITION OF PARALEGAL

As defined in WMPA's by-laws, a paralegal/legal assistant is a person, qualified through education, training and/or work experience to perform substantive legal work that requires knowledge of legal concepts and procedures and who works under the supervision of an attorney or is authorized by administrative, statutory or court authority to perform this work. This person may be retained or employed by a lawyer, law office, governmental agency, corporation, or other entity.

NATIONAL AFFILIATION

WMPA is a voting member of the National Federation of Paralegal Associations (NFPA), a national non-profit professional organization comprised of state and local paralegal associations. NFPA was founded in 1974 and currently represents thousands of paralegals. NFPA provides paralegal associations with information regarding issues affecting paralegals while presenting a unified voice for the profession on the national level. Every member of WMPA is a member of NFPA and receives NFPA's quarterly publication, The National Paralegal Reporter, in addition to receiving the benefits detailed at www.paralegals.org.

MEMBER SERVICES

- **Programs** - WMPA holds general membership meetings throughout the year for discussion and to present topics and speakers of professional interest. WMPA's annual meeting is held in April. WMPA also sponsors an annual dinner as well as holiday gatherings.
